- The Access and Service Delivery Committee reviewed and discussed the RBHA Service Data Report for 4<sup>th</sup> Quarter FY-20, the Crisis Intervention Triage Referrals Report, and Human Rights Report.
- One Human Rights violation was found and was resolved.
- Discussed status of REACH and the RICH Integrated Care Clinic and CCBHC overview.
- Determined upcoming Board Education Presentations through February 2021 and encouraged Board members to suggest any topics interested in seeing in future presentations.
- A draft report of the Access and Service Delivery Committee meeting is included in today's board meeting packet.
- The Access and Service Delivery Committee will meet again on December 1<sup>st</sup>.

#### **Executive Committee** – Dr. Cheryl Ivey Green

• The Executive Committee has not met since the last board meeting.

#### *<u>Finance Committee</u>* –Ms. Denise Dickerson

- RBHA's Net Assets or our net worth is healthy at \$14.2 million, excluding regional and non-agency, non-regional funds, and RBHA's share of net income is \$3.7 million.
- Total cash in the bank at July 31<sup>st</sup> was \$23.5 million, and RBHA's share of that cash is just over \$6.7 million.
- RBHA's current operating reserve ratio is at 1.51 or just under 3 months of expenses. This is a little higher due to vacancies and layoffs. RBHA is reporting monthly to DBHDS on COVID-19 issues including cash flows.
- Client accounts receivable is \$7.4 million. As part of the audit process. Finance is currently performing an annual lookback and write-off of items deemed uncollectible for timely filing. Accounts receivable figures for July are changing do to write-offs posted in July and then moved back to FY20 when the services were provided. Billing has also been delayed for various reasons including power outages, mold and work performed for the audit.
- The note payable balance at July 31 is \$3.1 million and has been recorded in the liabilities section of the Balance Sheet.

#### Richmond Behavioral Health Authority Board of Directors Chief Executive Officer's Report October 6, 2020

The beat goes on . . . We are in our **seventh full month of COVID 19 operations**. The significant service modifications we made in March are still in place, enabled by the flexibilities afforded by DMAS and the Department of Behavioral Health and Developmental Services. The **Marshall Center** has reopened with an enrollment of 40 (down from the pre COVID daily attendance of approximately 100). We have been delayed another week for reopening the **Therapeutic Day Treatment** program which will operate at Blackwell Elementary. The delay appears to be due to final details being worked out between the Richmond Public Schools and the City of Richmond.

RBHA has not been immune from the Coronavirus. To date 38 of our consumers have been infected and 11 of our staff.

RBHA, and much of my time over the past month, has been directed toward several city initiatives. The **Mayor's Task Force for Reimagining Public Safety** meets bi-weekly and will submit a final report within the next 45 days. I am supporting the **Human Services Lens** workgroup that meets weekly in addition to the full Task Force meetings. The Marcus Alert planning also continues. Last week a draft framework was submitted which consists of four components: 1) A special alert for police in the case of a behavioral health emergency, 2) A corresponder model involving pairs of police officers and crisis clinicians who partner full-time, 3) A collaborative response model involving a coordinated response between police and behavioral health, and 4) Enhancements to the current Crisis Intervention Team training. The Marcus Alert and Community Care Team(s) are still in planning and no final decisions have been made as to the framework and/or resources necessary to support.

The **Mayor's Office** also provided a press release in the last week, announcing a project in which behavioral health personnel will work with the Richmond Health District and the Office of Community Wealth Building at some of the health district's Community Resource Centers. The Mayor intends to fund a one-year pilot from FY 20 funds. It is likely that RBHA will be funded to provide a licensed clinician, a substance abuse counselor, and a peer.

The final walk through/approval of the **Children's Services Center** at the North Campus was completed on September 21. We are awaiting the Certificate of Occupancy. This reawakened structure will serve us well.

The **final settlement** with Haley for the renovation of the Women's Treatment Center is complete.

CEO Report October 6, 2020

The North Campus has initiated a **COVID 19 testing protocol** in partnership with LabCorp. Initial testing focused on 50 residents. All results were negative. Testing is now conducted with all new admissions.

The **VACSB Virtual fall conference kicks off at 10:30 this Wednesday**. Council meetings, the ED Forum, and the combined Board/Business meeting will be live on the platform sent by email to all registrants. Breakout sessions, while also live, will be available for view upon demand.

**NAMIWalks Your Way 2020** is just 5 days away. The RBHA team is still recruiting and has planned a celebratory event for Friday. If you are interested, let us know and we will resend sign-up information.










### UNRESTRICTED FUNDS




**Unrestricted Funds**



### What is Mental Health First Aid?

Mental Health First Aid is a structured course that teaches you how to identify, understand and respond to *signs* of mental illnesses and substance use disorders.

Mental Health First Aiders are anyone who wants to make their community healthier, happier and safer for all.








# Why Do We Need Mental Health First Aid?

How many times have you attempted suicide in the last 12 months? YRBS High School Data



 187 City of Richmond high school students reported to have seriously considered attempting suicide during the past 12 months. (YRBS, 2019)

 142 City of Richmond high school students reported to have made a plan on how they would attempt suicide in the past 12 months (YRBS, 2019)

### Why Do We Need Mental Health First Aid?

- Data indicate 40% of Richmond residents report having poor mental health compared to 29% statewide.
- According to 2017 data from the CDC's 500 Cities Project, nearly one in four adult residents of Whitcomb and Gilpin Courts reported that their mental health was not good at least 14 out of 30 days in a month, and nearly one in five Hillside Court residents reported the same.

# How do I get trained?

As of October 16, 2020 Mental Health First Aid will be offered, virtually, on a Monthly basis.

2 segments:

- 4 hour session and independent study
- 4 hour session via ZOOM platform with instructor


